USE OF THE LOGO IS VOLUNTARY

In case of suspension or withdrawal of the certificate it is prohibited to use the certificate and logo ACT and any reference to the certification.

• <u>It must be clear</u> that the certification relates exclusively to the certified management system and that it is not a product certification

- The standard applicable to the Certified Management System <u>must be reported</u>
- The search for certified companies is available on the website <u>ACT</u> <u>www.acubetic.com</u> <u>Management System</u>

THE LOGO CANNOT BE REPRODUCED

• Altering the proportions or separating the components

- On products or their packaging, both internally and externally, including labels and booklets with explanations of use
- On laboratory or inspection reports
- On material relating to products/services/production sites that are not covered by the certification purpose
- On any attestations or certificates of qualification and/or competence issued by the client organisation

USE OF ACCREDITATION LOGOS BY CERTIFIED ORGANISATIONS

FOR CERTIFICATIONS ISSUED UNDER ACCREDITATION, IT IS PERMITTED THE USE OF THE LOGO OF THE ACCREDITATION BODY BUT ONLY IN CONJUNCTION WITH THE A CUBE TIC LOGO







IN ORDER TO USE THE LOGO, IT IS **NECESSARY TO** PAY ATTENTION FOLLOWING REQUIREMENT

- The logo of the Accreditation Body <u>must always appear</u> alongside the ACT logo
- The Accreditation logo <u>must show the accreditation number of ACT</u> if present in the submitted file (e.g. UKAS 0273)
- Between the ACT logo and the Accreditation Body logo no other elements can be inserted
- The ACT and accreditation logos must <u>be reproduced using the same height</u>, if enlarged or reduced they must retain the same proportions and remain readable
- IT IS FORBIDDEN to use the Accreditation Body Logo, even together with that of ACT, on any technical documentation that may be associated with the product, when the organisation has a certified Management System (e.g.: declarations of conformity for the purposes of CE marking test certificates, etc.).

THE LOGO CANNOT BE REPRODUCED

• In any form that may be interpreted as a direct approval of the client organisation by the accreditation body

• In any form that may be interpreted as an approval of the <u>national authority supervising the accreditation body.</u>

SPECIFIC REQUIREMENTS FOR UKAS LOGO



- The reference height of the logo for an A4 sheet is 30 mm dimensions may vary proportionally depending on the size of the printing surfaces
- The logo may not be less than 20 mm high (excluding the accreditation number which will be adjusted proportionally) exceptions to this measure are possible in exceptional cases, but the logo must be legible throughout
- UKAS marks may only be used by A Cube Tic clients in connection with the issue of UKAS accredited certification and in conjunction with the A Cube Tic's mark, as shown in the example. Holders of certificates issued by A Cube Tic may use the appropriate national accreditation mark on stationery and publicity material. For the purposes of these conditions the term 'publicity material' shall not include notices, labels, documents, or written announcements affixed to or otherwise appearing on goods or products unless the goods or products. This restriction shall also apply to primary (Example blister packs) packaging and promotional products. The terms 'publicity material' and 'advertisements' shall not include notices, labels, documents or written announcements affixed to.

SPECIFIC REQUIREMENTS FOR UAF LOGO



- UAF marks may only be used by A Cube Tic clients in connection with the issue of UAF accredited certification and in conjunction with the A Cube Tic's mark. Holders of certificates issued by A Cube Tic may use the appropriate national accreditation mark on stationery and publicity material. For the purposes of these conditions the term 'publicity material' shall not include notices, labels, documents, or written announcements affixed to or otherwise appearing on goods or products unless the goods or products. This restriction shall also apply to primary (Example blister packs) packaging and promotional products. The terms 'publicity material' and 'advertisements' shall not include notices, labels, documents or written announcements affixed to or otherwise appearing on the vehicles or flags.
- The UAF logo shall **NOT BE APPLIED** to laboratory test, calibration, or inspection reports
- SIZE: When the A Cube Tic /UAF mark is printed on an unfolded portion of stationery sized no greater than A4, UAF symbol shall normally have a <u>minimum height of 10 mm and minimum width of 15mm</u>. Any enlargement if necessary, provided that the original proportion between the height and width of the symbol will not be affected and the symbol remains legible. magnifying glasses). The Symbol shall not be displayed in a more prominent way than the logo of the A Cube TIC Limited.
- INFORMATION FOR FULL COLOUR REPRODUCTION OF ACCREDITATION LOGO AND SYMBOLS: The Symbol shall be displayed <u>only in the appropriate form</u> and colour as demonstrated on page 19 of this file. The Symbol may be used in the defined colours or black and white colours provided that the conditions set out in this document are fulfilled.

SPECIFIC REQUIREMENTS FOR ACCREDIA



• The minimum dimensions of the ACCREDIA logo must be as follows, <u>Height: 12.6 mm, Width: 10.0 mm;</u> the dimensions may vary proportionally depending on the size of the printing surfaces

- The certified company must **NEVER** use the ACCREDIA Logo separately from the ACT Logo
- The certified company must **NEVER** use the ACCREDIA Logo in a way that implies ACCREDIA has certified or approved the company's management system, or in any other **misleading manner**
- The certified company may use a statement without applying the logo, such as "Organization with certified management system (e.g., quality, environment)," the name of the accredited body, and the applicable standard

- The use of the ACCREDIA Logo, in conjunction with the ACT Logo, is allowed on letterhead and general documents (excluding any technical documentation related to the manufactured products) or on assets and instrumental means used for the implementation of processes within the scope of the certified management system (such as commercial vehicles, buildings, lab coats, work overalls, and similar items), except for objects that are subject to specific certification, especially if mandatory or regulated (machinery, equipment, personal protective devices, etc.).
- For use on assets and instrumental means, the combination of the two Logos must be accompanied by the addition of a statement such as "Organization with certified management system (e.g., quality, environment)," the name of the CAB (Certification Accreditation Body) and the applicable standard.
